At the end of May, the Chess Federation of Montenegro started the implementation of the program. Teachers were surveyed on the way chess sections work, the number of interested students, and the necessary props. Based on the statements of a large number of teachers, it was concluded that it is necessary to unify teaching in all sections by developing appropriate textbooks. The previously mentioned was regarded as the first step. After a detailed analysis of all possibilities, we made a decision to translate three textbooks for children from the Russian language: "Through the world of chess with a raccoon", written by Ekaterina Volkova and Ekaterina Prudnikova. In cooperation with the publishing house Obodsko slovo, the copyrights were purchased, the books were translated into Montenegrin language and the printing was completed. A total amount of 6000 copies was printed, 2000 copies each book. In order to adapt the work of the sections to the online teaching, according to the curriculum, the internet program was developed. The development of the program is in the final phase, only the proofreading is ahead.

Several future coordinators (teachers) in the program participated in FIDE seminars for trainers for professional development. A seminar for chess arbiters was organized - an initial level for work in schools. An agreement on cooperation was signed with the Montenegrin School Sports Federation, which is authorized to organize school competitions at all levels in 6 school sports (football, basketball, handball, volleyball, athletics and chess). In over 50 schools, the formation of chess sections is being prepared, with a large number of students. The major issue is that due to the COVID-19 pandemics, schools are constantly changing their mode of operation from part-time schooling to the online way of schooling. MCF plans to promote chess in schools by organizing simultaneous games , workshops, and lectures in all municipalities in our country. Some schools have already started organizing their championships online.

#### 3. Summary of Project Outcomes:

Three textbooks have been translated from the Russian language and printed in 6000 copies. An internet application has been developed in order to teach children chess through play. The FIDE Logo is displayed on the application's website. Chess sections are currently being established in over 50 elementary schools. The supply of schools with the necessary props (textbooks, chess tables, chess clocks/timers, etc.) has begun as well as the training of teachers who would teach those sections, both in a classical way and via the Internet. Teachers are being trained to use the "Tornelo" platform for organizing online school competitions. Several future coordinators (teachers) in the program participated in FIDE seminars for trainers for professional development. A seminar for chess arbiters was organized - an initial level for work in schools.

An agreement on cooperation with the Montenegrin School Association was signed and it refers to the organization of chess competitions from the school level, municipalities, and regions, up to the state level. This competition program begins at the beginning of the second term of the school year.

Lessons Learned/Future Improvements:

Chess in school program is a very complex job and in Montenegro can be implemented only in cooperation with the relevant state bodies and authorities, and the school sports federation. The program furthermore, requires long-term effort and planning. The CODVID-19 pandemic has made the task much more challenging, but it has also shown that it is possible for sections to work online. It is necessary to raise the interest of elementary school students in chess with attractive promotional actions (chess days, simultaneous games,...). One of the main tasks is the training of teachers for the work in chess sections in elementary schools, but also their IT training. It is necessary to create a larger base of professionals who will coordinate and implement the process of teacher training, popularization of chess sections, and organization of school competitions.
