Note 1 <u>Currencies</u> Payments_were made in GBP and are here converted to USD at the actual rate of exchange at the date of receipt of the FIDE funds.

Note 2 Junior Training Programme This is deferred pending over the board activity after covid.

Note 3 <u>Arbiter Training Programme</u> An initial course was organised in October/November 2020, and 3 persons passed the required theoretical sections. We now await the resumption of over the board chess to allow these candidates the opportunity to gain the norms required for the arbiter licence. A further course will be held in February 2021 for an additional 2 candidates.... again the process will be completed on the resumption of OTB events.

Note 4 <u>Online Coaching Programme</u> This is an ongoing process which started in 2020 and will continue into 2021.

Note 5 <u>Rating / Membership Programme</u> Initial discussions were held with representatives of the English Chess Federation with a view to a collaborative project. We were unable to reach agreement_and have decided to "go it alone". However, the time spent on these negotiations have delayed the start of our project. The initial system specification is now under way.... in addition to the sums actually spent to date, we have accrued a further \$750 as an estimate of work done to date. We hope that continuing the project in this way will be possible at a much lower cost than originally planned.

Note 6 <u>Online tournament entry</u> This IT system is being prepared on an event-by-event basis, for economic reasons. The work has been completed for certain events and will be continued into 2021 at an estimated additional cost of \$1,600.

Note 7 <u>Expansion of online Schools chess</u> Schooling in Wales has been very severely disrupted by the pandemic. Schools I different areas have opened and close at different times, sometimes with little advance notice. When closed, a change has been made to online learning. This has had a negative impact on our plans as (1) pupils have less time available for chess tuition, and (2) schools are reluctant to allow pupils to use their computers for activities other than normal lessons. We hope this position will change, but it is most dependent on the coronavirus status.

Note 8 <u>Replacing OTB events with online events</u> We have been very successful in devising and promoting new, online events in 2020. This is continuing into 2021 and we have further tournaments planned for February / March.

Note 9 <u>Reduction in fee income</u> The inability to hold normal league activities and popular tournaments has of course caused significant disruption. In mid 2020, when preparing the application for FIDE funds, we thought it may be necessary to reduce membership fees for season 2020/21. This reduction was included in our application, at a cost of \$2,400 in 2020. As time passed, it became increasingly clear that the members of the WCU were reluctant to renew their membership without enjoying over the board events. The Management Board were most concerned over the possibility that a rival organisation, running online chess in Wales, and outside the auspices of FIDE, would be started and result in many members failing to renew WCU membership. Consequently, the Management Board determined that all membership fees would be waived for the period September – December 2020, as a minimum. A decision on fee levels for January – August 2021 will be made in the coming months. **We feel this action is critical to the continuation of chess in Wales, as we know it**.

The value of \$4,320 shown above represents a 4-month portion of the fees for a full season, assuming no reduction in membership numbers.
