The Association is required to measure the success of its events using the KPIs listed below. It is possible that an Association may not be able to report on a particular KPI and this will be taken into consideration at the end of the reporting period. s can also make use of the '**Comments**' field as required. The Association is also allowed to include any additional KPIs (Other) that it considers to be relevant for reporting purposes.

When the Association is preparing its final report for the end of the reporting period, the **actual** values of the KPIs need to be completed for each KPI identified.

#### **KPI STRUCTURE**

The KPIs' shall be divided into 4 main categories as follows:

**Core:** These KPIs are related to the technical operations of the Association. It includes number of active players, titles of players etc...

**Social/Special:** These examine the engagement in additional programmes related to the work of other FIDE Commissions and their priorities. They include: females, kids/chess in education, vulnerable groups (refugees, people with special needs, chess in prisons etc.).

**Promotion:** This includes the focus on the dissemination and profiling of chess activities of the Association and FIDE support. This should include mainstream and social media. This can allow for increased exposure and additional support.

**Partnerships:** This includes sponsors, strategic partners whose objectives are aligned to the federation. Strategic partners can include other government agencies, NGOS, media outlets. This indicator can impact the sustainability of the association.

Of course, Associations can also include any other KPIs they see as relevant to their operations.

The KPIs are listed in the table below.

#### Work of the Balkan Chess Federation:

At the meeting held during the 44th Chess Olympiad in Chennai, it was agreed to restart the work of the Balkan Chess Federation. Moldova's request for membership was accepted, it was agreed to hold the two mentioned competitions, while Mr. Erald Dervishi was elected president and in charge of further coordination of activities. <u>https://we.tl/t-azCRrK4quz</u>

#### During the BALKAN YOUTH CHESS CHAMPIONSHIP 2022 STANDARD, RAPID & BLITZ,

Board meeting of the Balkan Chess Federation was held. BCF expressed its great gratitude to FIDE for the support of its activities, without which they would not be possible. The President od BCF Mr. Erald Dervishi informed Board regarding the registration status of BCF in Tirana and the proposal of the competition for 2023 was adopted. It was agreed to organize BALKAN YOUTH CHESS CHAMPIONSHIP 2023 STANDARD, RAPID & BLITZ, Balkan youth Team championship, Balkan individual Championship, as well as a series of camps for the youngest members of the BCF. During Balkan youth team championship Mr. Dervishi presented the logo of BCF, the statute of the organization and the composition of the bodies. The statute and the necessary information are attached to this email. Legal registration is in the final stage, so BCF will soon become a legal entity.

Cooperation with the Chess Kid platform was also agreed upon, which we consider a success.

As can be seen in the recordings and photos from the two competitions, the FIDE brand was profiled. The opening of each competition started with the FIDE anthem

About Balkan chess federation and the aforementioned tournaments were reported on a daily basis via Facebook, newspaper, as well as the official websites of the competition organizers.

TV show "Chess for everyone", which is broadcast once a week on Montenegrin national television, was dedicated to the Balkan competition.

## • Budgeted versus actual income and expenditure including: FIDE contributions vs Association contributions and explanations of any differences.

The entire budget allocated by FIDE in the amount of 12,500 euro was spent on the accommodation costs of the players, members of the BCF. Namely, at the BALKAN YOUTH CHESS CHAMPIONSHIP 2022 STANDARD, RAPID & BLITZ, each federation had the right to free boarding for 13 members of the delegation (12 players and the road leader), while at the Balkan team, each team was provided with free accommodation for 6 members of the delegation. The costs, which were through funds provided by FIDE, were covered by the organizers of the competition from their own funds and sponsors.

#### • Lessons Learned.

All those present at the first meeting held in Chennai stated that the establishment of the Balkan Chess Federation is necessary, and that a special emphasis in its work should be the organization of competitions and camps for young people. In this way, young chess players from the member countries would have a great opportunity to get a taste of their peers from the region after the national championships, which represents a great rehearsal before participating in European and world competitions. The first two competitions attracted a lot of attention and passed with a satisfactory number of participants, considering that there was an overlap with some federations' calendars. That's why the Statute stipulates that BCF has its own bid procedure, like ECU and FIDE, so that competitions are held in optimal terms.

It was established that in addition to the competition, there is a need to organize youth camps, as well as a senior championship of the Balkans, which would be held as part of one of the grand openings in the member countries.

#### • The way forward for the Association.

The potential problems in the organization so far, related to the dates of the competition, are regulated by the application procedure and the Statute. A precise and well-designed calendar guarantees a large response of competitors and mass competitions, which is one of the prerequisites for the quality work of the federation.

The first actions and competitions guarantee future progress and success of BCF.
