Beginners Course - Due to issues obtaining a venue this was delayed but commenced on 25th January.

Club Equipment - The purchase of 20 DGT2500 Chess Clocks has been completed, however the 30 boards & sets have been ordered in 2023 but due to a shortage of stock DGT has not yet competed the order and we are still awaiting invoice & delivery.

Marketing & PR - We are awaiting approval from the Development Commission in respect of our October re-submission before proceeding.

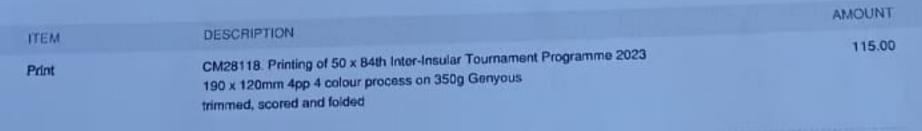
