PROJECT DESCRIPTION:	As part of this strategic framework, we submitted to FIDE in 2019 a project entitled "Chess in schools in five regions-Phase 1". This first phase mainly took place in 2019-2020. This approach has been very successful. We have succeeded in training a hundred young people by setting up training programs in Dakar suburbs, Thies and Saint-Louis. Currently, we are receiving training requests from all over Senegal. But we have difficulty in satisfying all the requests because of two constraints: insufficient chess boards and insufficient number of trainers. Therefore, in 2023, we decided to scale up our training programmes by betting on two strategies: • strengthen the support given to existing projects; • develop new training projects in additional regions which are Kedougou, Ziguinchor and Kaolack. But Kedougou and Ziguinchor being quite remote regions, we had to replace them with projects in Matam and Kaffrine. We have also had sponsors, including the Ministry of Sports, who have failed to meet their financial commitments. As a result, a large part of PDC funding was used for the organization of national competitions and participation in international competitions: Senegal Championship, U20 national tournaments, African Junior Championship, Chess International Day, etc.
